## Agreement – Entry card – Tromsø Climbing Club (TKK)

Entry cards giving access to TKK's climbing facility in Tromsø Tennis Club's (TTK) sports hall (Tennishallen) at Dramsveien 200, Tromsø can be distributed to the following who are involved in climbing activities in the hall:

- Members of TKK, 15 years or older. In order a youth under 18 years of age to receive an entry card a parent or guardian must sign the agreement and take responsibility for the youth. The parent/guardian will be responsible for points 1-12 below.
- Course instructors, climbing instructors, etc who have an agreement with TKK

## Those who receive an entry card (recipient) acknowledge:

- 1. That a requirement for having an entry card is that the recipient has paid all fees owed TKK. Entry cards can be rescinded in the case of unpaid debt to TKK.
- 2. That the recipient has learned the fire safety rules that apply to the hall, is familiar with the use of the fire alarm control unit, fire extinguishers, how to identify activated fire detectors, use of emergency exits, and that the exitsr shall be kept free of any obstructions by the recipient.
- 3. That use of entry cards is logged by TKK and TTK.
- 4. That the recipient has a valid "brattkort" (indoor climbing/belay certification from NKF) or equivalent from a nordic country (Sweden, Finland, Denmark).
- 5. That Tennishallen is monitored by security cameras.
- 6. That only the registered recipient can use the entry card. The card cannot be loaned to others.
- 7. That the card can only be used to give the recipient and other paying users access to the facility. Others cannot be granted access without an agreement with TKK. Organized activities are not allowed without advance approval from TKK.
- 8. That the recipient is responsible for any losses that TKK or TTK might suffer as a result of the entry card being lost or misused. Notify Tromsø Klatreklubb immediately if the entry card should be lost or stolen. A new card will cost 100 kr.
- 9. That the recipient is responsible for any losses that TKK or TTK might suffer as a result of vandalism of the building or its contents caused by the recipient or people to whom the recipient has granted access to the facility.
- 10. That responsible and safe behavior is expected while staying or climbing in the facility and the building in its entirety.
- 11. That anything missing or problems with the facility and/or equipment must be reported to TKK. Updated contact information will be available in the hall.
- 12. That vandalism caused by others must be reported to TKK or TTK.
- 13. That the recipient learns where the facility's light switches are and how to operate them. The recipient is required to turn off all lights and ensure that the outer doors are locked if s/he is the last to leave the facility.

<ul><li>14. That the recipient is aware that misuse of the entry card can lead to:</li><li>1. A warning</li><li>2. In the case of multiple offenses; exclusion from use of the facility</li></ul>
